
The Final Voters' List has also been posted in the ICAB web-site address <http://www.icab.org.bd> for kind information of the members.

The Nomination Forms of Candidates willing to contest in the election to the Council and Regional Committees should be sent to the Election Commission in the specified form duly filled in by the date and time as mentioned in the election programme alongwith Bio-data as per Proforma. The candidates for the Council Election shall also enclose a **Pay Order/ Demand Draft of Tk. 20,000/- (Taka twenty thousand) only** in favour of ICAB as election fee {bye-law 22(1)}.
