Conversion Course (3rd Batch) on "IFRS Framework and Financial Reporting in Conformity with BAS Requirements" for the old stream students on transition to Professional Stage (Application Level) Examination


With reference to Institute's Circular No. 1/15/ICAB-2010 dated 28 March 2010, this is for the attention of the students who have passed 'Advanced Financial Accounting' paper under the recently discontinued Syllabus of Professional Examination (PE)-II are required to successfully complete a Conversion Course on 'IFRS Framework and Financial Reporting in Conformity with BAS Requirements' in order to get exemption from 'Financial Accounting' paper under the newly introduced curriculum of Professional Stage (Application Level).

The duration of the Conversion Course will be 30 hours. Students will be assessed on the combined results of end-of-course test, attendance records and in-course test (s) by teachers. If on assessment a student does not pass, he/she will have to pass the re-sit test (s) to be arranged within 02 months after the end-of-course attended earlier. Students, who will not satisfactorily complete the course, will have to sit and pass the 'Financial Accounting' paper of Professional Stage (Application Level) examination.

The Conversion Course (3rd Batch) on 'IFRS Framework and Financial Reporting in Conformity with BAS Requirements' will be held at ICAB Academic Campus as per following schedule:
