ICAB National Conference for Chartered Accountants Bangladesh must get its share of G-20 Recession Package, says Commerce Minister

onourable Commerce Minister, GoB Mr. Muhammad Faruk Khan, MP said that the government has decided to go for an all-out effort to get Bangladesh's share from the

recession package announced at the G20 summit last month. "The government will ensure Bangladesh's part. We must fight for it," he expressed his high hopes at the conference. Mr Khan blamed the developed countries for the financial crisis and said it has been created for their wrong policies. "Why should the developing and poor countries suffer for them?" the minister questioned. He said the government is working out the country's requirements to tackle

the fall out stemming from the global financial crisis. The Minister said, "We must fight for our peg. We will discuss with our neighbors on how we can proceed regionally for the assistance." He said

that the government has already announced a stimulus package worth Tk. 3,424 crore to help some sectors. "More, including policy supports, are to come in the upcoming budget" he said addressing the inaugural session of the National Conference for Chartered Accountants of ICAB as Chief Guest at a hotel on 09 May 2009.

Mr. K Z Islam FCA, Chairman, Conference Organizing Committee and Past President of the Institute chaired the opening session while Mr. Skeikh A. Hafiz FCA, President, South Asian Federation of Accountants and Member Council & Past President, ICAB was present as the Special Guest. The theme of the Conference was "Global Meltdown and the Accountants". Dr. Atiur Rahman, Governor, Bangladesh Bank presented the theme paper.

Highlighting the role of Chartered

Mr. Islam gave a detailed account of the ongoing global meltdown and cited several significant events that led world's major companies to struggle with the recession's impact

ICAB in his speech said, "the National Conference Chartered Accountants 2009 has provided platform for the participants for an analytical interaction

on the global economic crisis that has impacted most countries of the world including the developed and developing countries.

Over the last 36 years, the Institute has impressive contributions made promoting and consolidating accountancy profession in Bangladesh and has made its due position among the world community of accountants. ICAB is now a permanent member of different regional and international accounting and standards setting bodies including the International Federation of Accountants (IFAC), Confederation of Asia Pacific Accountants (CAPA), South Asian Federation of Accountants (SAFA) and other bodies."

"ICAB has been working as a body of professionals to deliver expert services to trade & business on financial, economic issues and to protect public interest. In Bangladesh, ICAB is also the custodian of the International Accounting and Auditing Standards which are adopted by ICAB in line with other Chartered Accountancy bodies of the world "he said.

"We are currently also involved in a two year Twinning Project with the Institute of Chartered Accountants of England & Wales (ICAEW).

In the very near future, our Chartered Accountants will also be at with the Chartered Accountants of ICAEW, for their initiative in developing and elevating our profession to an international standard" he added.

Mr. Ahmed focused on the theme of the National Conference of Chartered Accountants 2009 "Global Meltdown and the Accountants" and said that against the backdrop of the recession, many countries including the developed nations may face negative GDP growth in this year and also in 2010. With our main trading partners, namely the US, UK and EU already entering a phase of recession, export growth has fallen sharply in this SAARC region. As a result, IMF apprehends global growth to come down to 3% or even less than that in 2009.

The financial crisis has imposed a tremendous professional responsibility on the accountants of the world and reminded us of the need to be prudent, cautious and careful while preparing or auditing the financial statements of the entities.

Keynote Speaker Dr. Atiur Rahman presented the keynote paper "Bangladesh Economy: Enduring the Global Economic crisis and the Role of the Accountants". In his address as keynote speaker, the Bangladesh Bank Governor expressed his optimism in overcoming the

effect of the ongoing global recession.

"After the current fiscal year, Bangladesh is likely to come out as the top success story in the world handling crisis like the ongoing

recession," said the governor. According to him, Bangladesh economy has been among the least affected in the world because of its domestic market emphasis. "International market concentrated economies, like China and Singapore, have been the worst affected by the recession. While Bangladeshi economy managed a narrow escape, as we have worked so much over our domestic market demands that made us strong within," he added.

The central Bank governor also praised the country's banking sector for their outstanding crisis management mechanism. "When banks, mostly of the developed countries, are looking towards their governments to rescue them by financial assistance, banks in Bangladesh have emerged as rescuers of other financial institutions instead of seeking succour from the government" Said the BB governor.

Mr. Sheikh A Hafiz FCA said that

accountants should he held not responsible for the global meltdown. This meltdown was caused by collapse of the US mortgage market and the reversal of housing boom.

Unnecessary aggressive banking is also blamed for this, he added. Mr. Hafiz also said that in many forums it has been said that the financial crisis resulted from corruption. He hoped that Bangladesh will not be affected very much by the global meltdown.

Mr. Md. Shahadat Hossain FCA, Vice President, ICAB offered the vote of thanks.

presented the paper on the topic. Dr. AB Mirza Md Azizul Islam, Former Advisor, Caretaker Government, GoB conducted the session as Session Chairman.

Dr Jamaluddin Ahmed FCA in his paper said that recession and depression have occurred many times throughout history. To many they bring fear and uncertainty, but they are actually a natural part of the economic cycle. Recessions and depressions have many effects on the overall economy. To survive

and thrive in these environments requires that you understand what causes them and how those causes create positive and negative effects on the overall economy. Some of the positive effects include taking the excesses out of the economy, balancing economic growth, creating buying opportunities in different asset classes and creating changes in consumer attitude. The negative effects include rising unemployment, a severe slowing in the economy, the creation of fear and the destruction of asset values. It is by carefully understanding what recessions and depressions are that we can learn how to spot them-and protect investments from them.

Mr. Basu in his paper said that the slowdown in South Asian countries is very significant. Globalization and connectivity with the international market will have their impact. It is the failure of Governments to deliver effective global governance that is to blame foremost for the current global predicament. Resolving the crisis and avoiding its

recurrence has implications beyond the realm of banking and financial regulation, going to the heart of the question-how to revive and extend multilateralism in a globalizing world. It calls for global cooperation and global regulation.

Realizing the depth of the economic crisis, governments, political, business and community leadership are taking steps in the right direction. Thus, with collective efforts and strong will to overcome, it can be hoped 'if winter comes can spring be far behind'.

I would now like to touch on some of the major activities carried out during the month of May 2009 and also provide a brief snapshot of future activities planned for the month of June.

I look forward to continue to communicate with you through these pages to keep you abreast with the developments that are taking place in ICAB and our profession. However, I will try to keep this as short as possible to cover major activities.

Mr Muhammad Ali FCA, expired on the 5 May 2009 (Innah LillaheRajeun)

We were very shocked and saddened to hear the news of the untimely death of our respected member Muhammad Ali, FCA (Enrol. # 263), who expired in the afternoon of Tuesday, the 5th May 2009 (Innah Lillahe Wa Inna Illahe Rajeun). Namaj-e-Janaza of late Muhammad Ali was held at the Central Mosque of Niketon, Gulshan on the same day after Isha Prayer. President in a condolence message to Mrs. Ali, expressed our sympathy to his family and prayed for the salvation of the departed souls.

CPD Seminars

There was one CPD seminar held in May 2009 at Chittagong along with Workshop on Audit Practicing Manual (APM). Despite our intention to hold at least one CPD seminars in May at Dhaka, but we could not do so due to holding National Conference of Chartered Accountants 2009 and SAFA Board & Committee meetings. However, we arranged two technical sessions during this National Conference, for members to earn 8 credit hours for attending these two technical sessions. We will continue our efforts to hold adequate number of CPD Seminars in coming months. We are in touch with ICAEW representative to hold few more CPDs with their active support. I hope we will have few more CPD seminars through active support from ICAEW, in this year.

Workshops on Audit Practice Manual

A total of five workshops on Audit Practicing Manual planned, which was started from Dhaka on the 28th April. Out of these five workshops, two were successfully completed at Dhaka in April. The rest three were held in May, one workshop at Chittagong covering practicing members of Chittagong Region and two workshops at Dhaka covering Dhaka based practicing members. These workshops were conducted by Mr Nick Reynolds, ACA, an official from Quality Assurance Department of ICAEW.

Evening Coaching Classes

Pre-exam Coaching classes for all groups e.g. PEI, PEII & PE III were continuing in full swing till closer to the examination schedule. ICAB Council is fully focused on students' educational facilities including library facilities to increase pass rate in all professional examinations. Library operating time has been extended in May to help students to take final preparation before examinations. Council is also taking keen interest in activities relating to examinations and revision of syllabus under Twining Project. ICAB is taking all preparations for smooth switching over to new curriculum.

Professional Examination

A professional examination of ICAB has started from the 31st May (PEII & PEIII started from 4th June 2009) both at Dhaka and at Chittagong centres simultaneously. President & Vice Presidents visited centres to see arrangements for smooth holding of examinations. Controller of Examinations with the support from Dhaka Regional Council & Chittagong Regional Council made all arrangements for smooth & peaceful holding of examinations. Mr Showkat Hossain, FCA, Vice President stationed at Chittagong personally looked after all arrangements of holding examinations at Chittagong Centre.

Courtesy meeting with the Honorable Minister for Law, Justice & Parliamentary Affairs

President, ICAB, led a team comprising of Mr. Md Syful Islam, FCA, Vice President, Mr. A S M Nayeem, FCA, Mr. M Farhad Hussain, FCA and Mr. Md Humayun Kabir, FCA, Past Presidents & Council Members, met the honorable Minister for Law, Justice & Parliamentary Affairs on the 27th May, to discuss Financial Reporting Act related issues. The team discussed various issues relating to FRC & FRA and briefed the honourable minister about adverse effects of this Act on our profession, trade, commerce & industries of the country. We also informed him about the present

status of other countries in this region. We have been able to convince him of the need for his kind intervention. He suggested us to give a gist of our comments and recommendations to him, to enable him to take appropriate actions from his ministry.

Institute Chartered Accountants of Bangladesh (ICAB) organized a 5-day workshop in Dhaka and Chittagong for the Practicing Members of the Institute. He said that this manual took practicing members through all the stages of an audit from planning an audit through to assessment of risk and materiality, analytical reviews and detailed audit programmes.

Mr. Nasir Uddin Ahmed FCA, President, ICAB in a message expressed his hope that the application of APM in audit and assurance work could serve that purpose of the practicing members of the Institute. He also hoped that all practicing firms should

use such an audit and assurance guideline, compliance of which can provide it and users with reasonable assurance that the audit procedures were relevant, adequate and in accordance with BSAs

About the importance of the workshop Mr. Vernon Soare, Executive Director, Professional Standards, ICAEW said in a message, "The Audit Practice Manual (APM) incorporates all the documentation needed to enable compliance with Bangladesh Standards on Auditing and is based on the APM used by many ICAEW members throughout the UK". Four workshops were held at Dhaka and two were held at Chittagong. Mr. Mahbub Ahmed Siddique ACA, Deputy Director (Technical), ICAB and Mr. Juris Reinhards, Project Head, Twinning Project, ICAEW, ICAB helped Mr Nicholas on behalf of ICAB and ICAEW respectively.
